3. The undersigned reserve the right to add/delete or amend any recommendation deemed fit during future inspection and due to up gradation of firefighting monitoring system of this department in interest of life safety.
4. It is mandatory to the Owner or Occupier shall submit the "B" certificate by license Agency in the month of January/July 2025, otherwise shall render this certificate cancelled or invalid.
5. This Certificate is valid upto **31 Dec 2025**.
