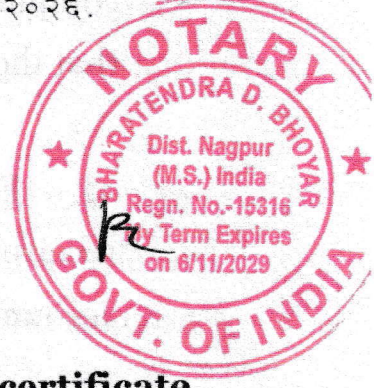

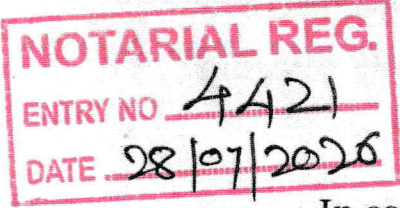

**Subject :- Regarding granting the approval certificate
Under Rule 11, Sub Rule 4 of Right to Free and
Compulsory Education 2009 under section 18
of Right of Children to Free and Compulsory
Education Act, 2009.**



In connection with your application dated 15/03/2026 as well as communication /correspondence with school and after verification, I Nilesh Gund, Education Officer (Primary) Zilla Parishad, Nagpur issued the temporary recognition for the period of 3 years from 01/04/2025 to 31/03/2028 to the Swaminarayan School, Wardhaman Nagar, Nagpur (English Medium), upon fulfillment of following conditions.

- 1] The approval period will not be extended and no recognition or affiliation shall be granted beyond the Class-VIII under any circumstances.
- 2] The School shall comply with the provision of Right to Children to Free and Compulsory Act, (Annexure -I) and Maharashtra Right of Children to Free and Compulsory Education Rule 2011 (Annexure-II).

3] The School shall admit the children from neighborhood area belongs to weaker section and disadvantage group to the extent of 25% of strength in entry level classes and shall provide them free and compulsory education until completion of primary education, provided that they shall also apply in respect of primary classes, if any.

4] For the children covered under para 3 above the school shall receive re-imbursement as per section 12 (2) of the Act : separate bank account shall be opened by the school for this purpose.

5] Institution/School shall not charge any capitation fee, and shall not subject the child or he/her parent of guardian to any screening procedure.

6] No child shall be denied admission to school for lack of proof of age, or on the ground of religion, caste, race or place of birth.

7] (i) No child admitted to the school, shall be head back in any class or expel from the school until completion of primary education.

(ii) No child shall be subjected to physical punishment or mental harassment.

(iii) No child shall be required to be passed any board examination until the completion of primary education.

(iv) Every child who completed the primary education, shall be given a certificate as prescribed under Rule 23.

(v) Differently-abled /special need student shall be accommodated as per the provision of the Act.

- 8] The school shall follow curriculum prepared on the basis of the frame work laid down by the competent authority.
- 9] The school shall comply with the norms and standard specified under section 19 of the Act, the facility at the school as recorded at least inspection were as follows :
- (i) Area of the school premises 8700 sq.mtrs.
 - (ii) Total constructed (built-up area) 4528 sq.mtrs.
 - (iii) Play ground area 5875 sq.mtrs.
 - (iv) Total number of rooms in school/ number of class rooms : 60/48.
 - (v) Office and Head master room : Available.
 - (vi) Separate, clean and hygienic toilet facility for boys and girls, with adequate water : Available (Boys- 5 toilets, 5 urinals, Girls – 50 toilets and, 5 urinals).
 - (vii) Drinking water facility – Available.
 - (viii) Kitchen for cooking mid-day meal – Available.
 - (ix) Teaching–Learning material/Sports and Game equipment/ Library – Available.
 - (x) Reading free material- Available (No. of books not specified- Library present)- Available.
 - (xi) Are all facilities available without any Hindrance? Yes.
 - (xii) Is there a security /boundary fence at the school? Yes.

11] No on recognized class shall or divisions shall be run within the school premises or elsewhere.

12] The school building or other construction / play-ground shall be used solely for the purpose of education and skill development.

13] The school is run by an Institution registered under Society Registration Act, 1960 (Act No. 21 of 1860) or Bombay Public Trust Act, 1950.

14] The school shall not run for the profit of any individual group, family or any other persons.

15] The school's account shall be audited by certified Chartered Accountant and proper account statement shall be prepared in accordance with the rules. One copy of annual account statement shall be send every year to the District Education Officer.

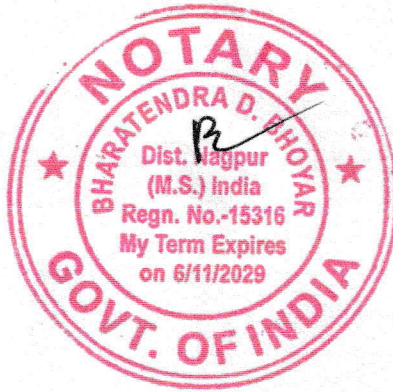
16] The Recognition Code allotted to your school is 27091505810. This code monthly quoted in all correspondence with this office.

17] The school shall submit such reports and information as may be demanded from time to time by the Director of Education/ district Education Officer and shall comply with the instructions issued by Government or local authority for continue compliance with the condition of recognition or for rectifying the deficiencies in school functioning.

18] It the registration of Institution requires renewal, the school shall ensure that, it has been renewed.

19] Other conditions attached as per Annexure shall also be apply.

20] As required under Right of Children to Free and Compulsory Education Act, 2009, the above mentioned deficiencies must be rectified by the school on or before 31/03/2028, failing which the schools recognitions shall automatically stand withdraw thereafter.

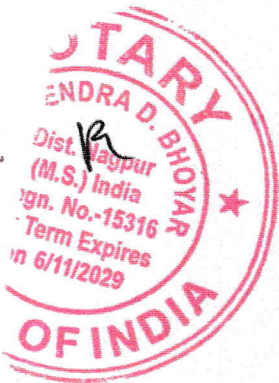
